Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to United Assemblies of Christ International, Inc., or the federal government, or to a state or local government, for public use. Any such assets not disposed of shall be disposed by the Court of Common Pleas of the county in which the principle office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

Monthly Support:

As a Chartered member church/ministry of the United Assemblies of Christ International, Inc. all chartered members are required to support the mission and ministry of United Assemblies of Christ International through monthly contributions. Contributions are to be mailed in along with a monthly Ministry Report no later than the 5th day of each month. Contributions are set by the size of the congregation/ministry and are as follows:
